Telecare Mona Hall Legacy

The United Way for the City of Kawartha Lakes is issuing a request for Letters of Intent to express interest in applying for funding available through a special opportunity provided by Lifeline Telecare Lindsay - the Mona Hall Legacy Fund. For 40 years Telecare provided an invaluable distress line for the community. Reassurance calls were made to people living alone, isolated, or having difficulty coping with day-to-day activities. In memory of an amazing woman, Mona Hall, a \$5,000 fund has been set up for organizations wishing to create opportunities for a better life for individuals, families, and communities by making our community a better place to live for everyone.

The Mona Hall Legacy Fund honours a strong independent woman who was involved in her community. She was a grocer by profession, but also found time to volunteer with her church, she helped organize a Lindsay Home Coming, was a member of the I.O.D.E., and an extraordinary collector of antiques. The auction of her collection drew collectors from all over the province. The legacy funds came from her antique collection. In later years she requested a reassurance call at 11:00 am Monday to Saturday from Telecare.

The Telecare Mona Hall Legacy will award \$5,000 to a non-profit organization/group whose project/program addresses an emerging or changing need in the City of Kawartha Lakes community.

The first step in this process is the completion of a Letter of Intent to express interest in applying for funding available through the United Way CKL. Potential applicants will then be selected and asked to submit a full funding application which will include Project Information, Community Need, Action Plan, Financial Requirements, Method of Outcome Measurement, and Evaluation Criteria.

ELIGIBILITY REQUIREMENTS

- Be a registered charitable organization or not-for-profit organization.
- Provide programs and/or services in the City of Kawartha Lakes.
- Have either a volunteer Board of Directors or demonstrate a form of governance.
- Able to provide evidence-based data to support your program.

EXPENSES NOT ELIGIBLE FOR FUNDING

- Major capital costs, renovation costs, deficits, and retroactive expenses or costs.
- General and administrative expenses not directly related to the project.
- Computer technology, travel expenses, or for-profit activities.
- Fundraising events or political activities.
- Incomplete applications missing information necessary to make an informed decision.

PLEASE NOTE: Letters of Intent received past the deadline will not be considered.
