

# **United Way Haliburton Kawartha Lakes Local Emergency Fund Guidelines**

The Poverty Reduction Strategy Report for the City of Kawartha Lakes and Haliburton County identified areas for focussed work and cross-sectorial investments. This report concentrated on proactive and reactive initiatives to help people in real time but with the goal to reduce and eliminate poverty. The key areas for attention included: children and youth, employment and training, education, food security, affordable/available housing and transportation. This fund prioritizes opportunities that provide emergency food, essentials, housing and well-being supports.

Requests of up to \$500 can be made through this fund.

#### **ELIGIBILITY CRITERIA:**

Applications are accepted from Registered Charities, and Incorporated Non-Profits.

- The organization focuses on supporting those living in, or at high risk of, food insecurity and other impacts of poverty
- The organization has existing, trusting relationships with members of a low-income community

Organizations that are **not** eligible to apply for funding include:

- For-profit organizations
- Hospitals
- Educational institutions and organizations, schools, universities or college administration and parent-teacher associations.
- Faith-based organizations that require an adherence to or promotion of a religious faith as a condition of receiving supports or services.
- Municipalities and entities controlled by a municipality including municipal governments, regional governments, and regional districts Individuals.
- Please Note: Funding cannot be provided directly to individuals, only to organizations.

### Eligible Expenses:

Gift cards or purchases related to the classifications listed on page 2.

Note: cash cannot be given to individuals.

Ineligible expenses:

- Administration costs including staff wages, utilities, overhead, etc.
- Capital or equipment costs

## Assessment of Application:

Applications will be accepted on a rolling basis until all funds are expended.

Applications will be reviewed upon receipt. Decisions will be communicated to applicants within a week of submission.
